# **Brafferton & Helperby Parish Council Annual Meeting Minutes**

# Wednesday 17 May 2023 Held in the Village Hall at 7.30pm

**Present:** Cllr Nigel Denison (Chairman), Cllr Peter Mitchell, Cllr Pam Jackson-Vickers, Cllr Mark Darwin, Cllr Deirdre Brown, Cllr Matt Boyle, Cllr Andy Gale and Roger Clements (Clerk).

- 1. Election of Chairman of the Council Cllr Mitchell proposed Cllr Denison for Chairman. No other proposals were made and Cllr Denison was elected unanimously as Chairman.
  - 1.1. Chairman's Declaration of Acceptance of Office Cllr Denison made and signed the declaration.
- 2. Apologies for Absence Cllr Alyson Baker (North Yorkshire Council).
- 3. Mr Gale had been accepted as qualified to be a parish councillor at the last meeting but had been unable to attend that meeting. The Declaration of Acceptance of Office was received from Mr Andy Gale and he took his place on the Council.
- 4. Vice-Chairman of the Council Cllr Mitchell was proposed by Cllr Jackson-Vickers to continue as Vice-Chairman **resolved**.
- 5. Declarations of Interest not already declared under the Council's Code of Conduct or members Register of Disclosable Pecuniary Interests no declarations were made.
- 6. To receive news from North Yorkshire Council (NYC). Cllr Alyson Baker had sent in a report:
  - 6.1. Sutton Bank White Horse maintenance was planned for 10 17 Sep 23 when the road access would be closed.
  - 6.2. Scarborough hosts the Armed Forces Day celebrations on 24 June with a free event comprising air displays, music, marching bands, exhibits and much more.

- 10.9. Council's Delegation Scheme the scheme had been circulated to Cllrs before the meeting. Chairman outlined the purpose of the scheme which provided clarity on the powers and actions which the Council delegated to its Clerk/Responsible Financial Officer. Cllr Denison proposed that the scheme be adopted by the Council **resolved**.
